

## Wi-Fi and Internet Access Terms and Conditions for Rentals and Leasing CBE Facilities

Individuals or Groups that rent or lease Calgary Board of Education (CBE) facilities are responsible for providing their own technology needs during the rental or lease period. CBE is not responsible for providing or supporting the technology needs during that period. All costs associated with deploying and supporting the technology needs is the sole responsibility of the Renter or Leaseholder.

Short-Term temporary (daily) Wireless and Internet Access is available via the CBE guest Wireless environment. Please reference the terms and conditions along with the guest access instructions below:

## **CBE Guest Wireless and Internet Access**

CBE technology services like that of the Wireless networks and Internet services are primarily to support the Learning outcomes of CBE Students. As such, priorities will always be given to ensure the Technology services are optimally designed, configured, supported and used in a manner that ensures CBE Students are able to leverage technology within our schools and facilities to achieve those outcomes.

CBE at its sole discretion may discontinue the service due to improper use or used for inappropriate purposes. There are no expectations of privacy for users of the CBE Wireless and Internet service and as such the use shall be at your sole risk and CBE shall be relieved from all liability in connection therewith.

Guest wireless hours of use are daily from 7:00 a.m. - 10:00 p.m. The offering for this service is "As-Is" with no guarantee of availability or expectation of support. While it is not the CBE's intention, the service could be discontinued at any time. CBE also reserves the right to make modifications to the service without notice.

The following are guidelines and/or restrictions to the use of CBE and non-CBE Technology within CBE schools and facilities:

- Must adhere to Administrative Regulation 1062 Responsible Use of Electronic Information Resources.

- The service is restricted to the schools <u>content filtering level</u>. The levels of restriction vary from school to school.

- Daily guest access requires daily login and daily acceptance of the terms and conditions before using the system.
- CBE Wi-Fi coverage may not be available to all areas within the site.
- There is no user support for non-CBE staff/students.
- There are no after-hours (non-school hours) support for wireless systems (even outages).
- Maintenance activities may occur after hours and services could be interrupted during this time
- Bandwidth rate limitations exist for daily guest users. High bandwidth applications (Netflix, YouTube) such as but not limited to high definition video streaming could be affected.
- Any costs to repair damage done to CBE Technology infrastructure within a CBE school or facility is the responsibility of the Renter or Leaseholder.
- Installation of any non-CBE equipment within a CBE data room is prohibited without prior authorization from the Information Technology Services department. Request for authorization to access or install any third party equipment in a CBE Data room can be made by calling or emailing the CBE IT Helpdesk at <a href="mailto:helpdesk@cbe.ab.ca">helpdesk@cbe.ab.ca</a> or 403-817-7777. Please allow five business days to process the request.
- Never connect unapproved devices like Laptops, Personal Computers, Printers, Wireless routers, Cable modems, Streaming Devices, IoT device etc. to a CBE wired network port without prior authorization from the Information Technology Services department.
- CBE Wireless or Wired infrastructure must never be tampered with or altered in any way, shape, or form.
- Any device that interferes with CBE wired or wireless networks will be disabled and/or disconnected without notice or recourse.
- Any costs to repair damage done to CBE Technology infrastructure within a CBE school or facility is the responsibility of the Renter or Leaseholder.
- No access to CBE systems such as school printers, school file shares or CBE internal applications is permitted.
