

TERMS AND CONDITIONS

SCHEDULE FOR CTS REBATES – 2010-2011

TO THE TRANSIT BUS PASS REBATE AGREEMENT

1. Students must meet eligibility criteria as outlined in AR6095 to be eligible for rebate.
2. In the event that approval is not granted for this application, the Calgary Board of Education will not be held responsible for Calgary Transit passes purchased presuming receipt of the rebate.
3. Expired passes must be shown to the appropriate school personnel by the stated deadlines. Failure to show a pass by the monthly deadline may result in forfeiture of the rebate for that particular month.
4. The students name must be printed neatly on the pass before it is shown for the rebate. Failure to print the name on the pass may result in forfeiture of the rebate for that particular month.
5. Rebates will be processed only through a direct deposit. Failure to provide the required banking information will result in no rebate being processed.
6. In the event of a disagreement between the applicant and the Calgary Board of Education, the records of the Calgary Board of Education shall, in the absence of obvious error, be considered correct.
7. The Calgary Board of Education is not responsible for lost or stolen passes.**
8. In the event that there are other fees or charges owing to the Calgary Board of Education from the Parent/Guardian or independent student such as school fees, the Calgary Board of Education reserves the right to retain the rebates for the purpose of deducting the amount of the rebates from the outstanding charges or fees owed to the Board.

Calgary Transit Passes can be purchased at most Transit outlets.

September Rebate may be delayed until November deposit date if completed form is not received by June 30, 2010.

Final Date bus passes will be accepted for the 2010/2011 rebate will be **August 11, 2011**. A copy of the front and back of the expired passes may be dropped off or mailed to the address on the front of this form if you wish to keep the original for the Federal tax credit. **DO NOT FAX**

*Note: Applications for a waiver of the cost of a Transit pass are available at the school. Passes for those with approved waivers can be picked up from the school office 3 days prior to the first of each month.

**Note: Retain receipts for bus pass purchases. In the event the bus pass is lost or stolen, rebate can be processed with proof of purchase.
