To lease a minimum area of 180,000 square feet and a maximum area of 220,000 square feet in a building to be constructed on the eastern one-third portion of the Dr. Carl Safran School site at 930 13 Ave. S.W., Calgary, Alberta, together with parking space underlying the building, the cost of such construction which forms the basis for the leasehold costs being currently estimated to be approximately \$88,000,000; and
- 2. To renovate the sandstone school building located on the central portion of the above described lands and to construct a new conference centre at the central portion, the costs of such renovation and construction being currently estimated to be approximately \$23,000,000, such renovation and construction to include parking space underlying the sandstone building.
