# CALL TO ORDER

## WHITE HAT CEREMONY

Dr. Croskery provided introductory comments for a very distinguished guest, Dr. Kong, Chief Superintendent of the Seoul Metropolitan Office of Education. Dr. Croskery stated that it was his distinct pleasure and honor to introduce Dr. Kong, and his delegation on his first visit to the Calgary Board of Education and provided detail of his education and experience. He made special mention that the interpreter was a Sir Winston Churchill High School graduate. He spoke of the relationship between Korea and the Calgary Board of Education and the educational opportunities that this has provided for both students and staff. A representative from Tourism Calgary was also present to welcome Dr. Kong and honor him with the presentation of a white hat. This hat is presented on behalf of the Calgary Stampede, as a western hospitality tradition that began 60 years ago and is extended to special visitors to our city. He also presented Dr. Kong with a certificate naming him an honorary citizen of Calgary.

Dr. Kong expressed his appreciation for the warm welcome and spoke of the relationship between Calgary and Korea that began during the 1988 Olympic games when both cities were hosts and became well known to each other. The relationship has been growing and he expressed his gratitude to Dr. Croskery for his part in developing this. He spoke of his desire that the relationship between the Calgary Board of Education and Korea remain strong. Chair Cochrane expressed thanks on behalf of the Board of Trustees, which was followed by an exchange of gifts between the Korean delegation and the Board of Trustees.
