1.0 CALL TO ORDER, NATIONAL ANTHEM AND WELCOME

Chair Cochrane called the meeting to order at 5:01 p.m. and the singing of the national anthem took place, led by grade 8 students Olivia and Sarah from Colonel Macleod School. Chair Cochrane acknowledged and welcomed representatives from the aforementioned organizations.

3.0 SCHOOL/SYSTEM PRESENTATIONS

4.0 HONOURS AND RECOGNITIONS

4.1 <u>Lighthouse Award</u>

Ms. S. Church, Director, Corporate Partnerships introduced the recipient of this month's Lighthouse Award as the Alberta Mentor Foundation for Youth (AMFY). AMFY is a not-for-profit organization that is dedicated to helping junior and senior high students to achieve their full potential through supportive in-school mentoring relationships. Adult volunteers spend one hour a week, one-on-one with a student, to motivate and assist students to set personal and academic goals, maximize their potential, consider future career paths and stay in school.

On behalf of AMFY, Ms. D. Rubenstein, Executive Director, accepted the award that was presented by Chair Cochrane. On behalf of the Board of Trustees, Chair Cochrane expressed appreciation for the partnership, noting that mentoring is a huge issue in today's society, and the work of AMFY has proven very effective.

5.0 PUBLIC CONVERSATION AND INFORMATION

5.1 Report from the Chair and Trustees

Chair Cochrane noted this meeting was the last opportunity to publicly say goodbye to Trustees Close and Fawcett, who were not running in this year's election. She noted her sadness about their leaving, but thanked them for their work and wished them every success in their future endeavours. Tributes were made to each of them for the fine work and contributions they made to the Board and to the Calgary Board of Education.

Trustee Close and Trustee Fawcett each expressed their appreciation for the kind remarks and shared their gratitude for having served as a public school trustee.

5.2 Report from the Chief Superintendent

Chief Superintendent Croskery commented on his visit to Central Memorial, Lord Shaughnessy, Juno Beach Academy and Lord Beaverbrook High Schools. He shared comments about the tragic death of a student from Central Memorial High School, and about how the CBE is dealing with that crisis as it affects students, staff and parents.

At this point in the meeting, on behalf of the entire system Chief Superintendent Croskery extended profound thanks for the Board of Trustees' efforts during the past three years. He noted that they have been a magnificent Board over extremely challenging years and during that time they were very powerful advocates for the citizens of Calgary, setting strong direction on their behalf and successfully implementing a world-class policy governance model. Chief Superintendent Croskery stated that the Calgary Board of Education could not have achieved a fraction of what has been accomplished without the Board's leadership and its focus, integrity and wisdom. He remarked that he has never worked with a more effective or more cohesive Board of Trustees. On a personal level, he extended his appreciation for the ways in which each one of the Trustees has supported his development as their Chief Superintendent. When he needed encouragement, Trustees provided it; when he needed their wisdom, it was offered; when he needed their support, it was unfailingly given by every one of them. He stated that he feels exceptionally privileged to have served for this Board of Trustees.

The members of Superintendent's Team shared comments and gave accolades to each of the Trustees and presented them with a token gift of appreciation as follows:

- Chief Superintendent Croskery paid tribute to Chair Cochrane and Trustee Dirks;
- Superintendent Dart paid tribute to Trustees Bazinet and Close;
- Superintendent Coppinger paid tribute to Trustee Lane;
- Director Brost paid tribute to Trustee Fawcett; and
- Director Kuester paid tribute to Trustee Ferguson.

5.3 Public Question Period

5.4 Stakeholder Reports

5.4.1 Ms. G. Burger-Martindale, Calgary Association of Parents and School Councils

Ms. Burger-Martindale noted they are an umbrella group for school councils and an advocacy group for students' education. At this time, every three years, they also take a strong stance in bringing awareness to the public about trustee elections and the importance of voting. To this end, in conjunction with the Alberta Teachers' Association they put together some questions for the trustee candidates to respond to, which are subsequently published in a newsletter. Ms. Burger-Martindale brought copies of the newsletter and encouraged that they be openly distributed. This information is also available on their website at www.capsc.ca. She noted further that they also run a series of trustee forums in each of the joint wards, which are listed on the back of the newsletter. She noted with apology, an error in the printing of the location for the forum for Wards 3 and 4 – it is to be held at Colonel Irvine School, not at Sir John Franklin School.

In closing, Ms. Burger-Martindale suggested that teachers of social studies classes (grade 6 or higher) might want to consider taking their students to the Nomination Day held in the Council Chambers of the City Municipal Building, to learn how that process is undertaken.

7.0 MONITORING AND RESULTS

7.1 Summary of the 2006-2007 Provincial Achievement Test and Diploma Examination Results

Chief Superintendent Croskery provided opening remarks noting that the CBE takes pride in its commitment to a comprehensive balanced model for assessing student learning. Within this model, the standardized provincial testing program is one part that offers valuable insights into student achievement. This report summarizes CBE achievement test and diploma examination results for 2006-2007, and the results are analyzed in two ways – firstly, in comparison to provincial results, which includes CBE results; and secondly, in comparison to previous years' results. Chief Superintendent Croskery stated that once again, CBE students have demonstrated consistent, solid performance across the spectrum of tests. On the vast majority of measures, CBE students perform at higher levels than other students from across the province, and this is a remarkable accomplishment in view of the complexity of our student profile. It was noted that Area Directors and Accountability Services staff, including Director Brost, were available to respond to questions.

Administration addressed questions that were posed by Trustees, with regards to the following issues:

- High achievement areas include the results from our English as a Second Language students, of which the CBE's cohort is approximately 50% of the total province's. This is a disproportionate number of students since we only have about 17% of the overall students in the province. Another area of high achievement is in the Sciences, particularly in Chemistry 30 and Physics 30, as well as in Pure Math 30. In terms of some of the challenges, although our results compare very well to the province and very well to past years, we still have a significant percentage of students who are not achieving at levels that we would like them to achieve at. Areas of challenge include the Grade 9 Math and Science results, which may be attributed to issues surrounding the curriculum itself or the actual tests. The areas of challenge are continually being reviewed throughout our system to determine how to move forward to better the achievement of our students. It was noted that one of the projects through Alberta Initiative for School Improvement (AISI) that we are looking at is around curriculum and diversity.
- With respect to the variation in results from school to school, it was noted that every school will review the overall results and will be influenced by them in the structuring of their school development plans, which would in turn influence the Area plans.
- It was noted that the CBE was asked by Alberta Education to discuss promising practices to share with other jurisdictions, because they noticed many areas where the CBE was improving significantly. Alberta Education also works with jurisdictions that may be struggling in certain areas of student achievement.
- Test equating involves the repeated use of certain questions from one test to another and this has been in place for quite some time for the provincial achievement tests and only for a few years for the diploma examinations.

- The CBE participation rates for English Language Arts 30-2 are lower than the province's but our student participation rates for English Language Arts 30-1 are higher, which is an indication that we have a higher number of students taking the higher course level.
- The effect on our results from having a higher percentage of English as a Second Language and Special Education students was discussed and it was noted to sometimes have a negative impact on our results. Although we are proud of how well these students are doing, they are not doing as well in general as the non-coded students.

MOVED by Trustee Lane:

THAT the Board of Trustees receives the Summary of the 2006-2007 Provincial Achievement Test and Diploma Examination Results for information, in the form as submitted.

7.2 Annual Monitoring Report – Executive Limitations 4: Treatment of Parents and Citizens

Chair Cochrane reviewed the criteria against which the Trustees are to judge the monitoring report on Executive Limitations 4: Treatment of Parents and Citizens, including that of reasonable interpretation of the policy, whether the Board is satisfied that the Chief Superintendent is in compliance with the policy provisions or has disclosed procedures to establish compliance, and whether sufficient information has been provided. She noted further that any decision or comment of the Board of Trustees with regard to noncompliance is in no way intended to be a vote of non-confidence for the Chief Superintendent.

Trustees posed questions, which were responded to by Administration, and the discussion is summarized as follows:

- It was noted that during the 2006-2007 school year, there were no special education appeals and no breach of privacy complaints received or investigated by the Office of the Information and Privacy Commissioner, which is an improvement over previous years.
- With respect to efforts that have been made to address public issues and questions in an effective and efficient manner, Director Kuester noted that the 311 system that was put in place by the City of Calgary was a major investment on their part and they have indicated that they have the capacity to perhaps take on that role for the CBE as well.
- Clarification was provided about the requirements that have to be met before a research
 project is approved by Accountability Services, including the requirement that it would
 have a positive impact on our students, it is ethical, it remains anonymous, it receives
 security clearance, etc.
- In regards to the individual school websites, there is an Administrative Regulation that requires they be maintained and updated by the respective principal, and this work is improving throughout the system.

MOVED by Trustee Bazinet:

THAT the Chief Superintendent has reasonably interpreted the provisions of Executive Limitations 4: Treatment of Parents and Citizens, and the Board of Trustees finds the Chief Superintendent to be in compliance with the policy.

Comments in support of the motion included that information in the report shows that Administration has provided ample opportunities of involvement in the system for parents and citizens; and that the report shows a great breadth and depth of open communication with our public and widely demonstrates the facilitation of interaction for student learning.

Chair Cochrane called for the vote on the motion.

The motion was CARRIED UNANIMOUSLY.

MOVED by Trustee Dirks:

THAT the Board of Trustees commends the Chief Superintendent for the continuing improvement in the number of parents who express satisfaction with the opportunities to be involved in decisions about their children's education.

The motion was CARRIED UNANIMOUSLY.

MOVED by Trustee Dirks:

THAT the Board of Trustees commends the Chief Superintendent for the quality work that was done this past year by the Community Engagement and Operational Planning department.

The motion was CARRIED UNANIMOUSLY.

7.3 <u>Annual Monitoring Report – Executive Limitations 7: Treatment of Staff and Volunteers</u>

Trustees posed questions, which were responded to by Administration, and the discussion is summarized as follows:

- Administration expanded on the details surrounding the refinement of teacher identification and selection criteria in support of our Special Education programs; as well as on the recruitment measures and increased number of teacher applicants.
- Most of the staff transfers occur during the spring staffing process, primarily through May and June. With regards to teacher transfers, a two-year requirement is placed on the incumbent teacher to a new position.
- Speculation was given to the potential need for the implementation of a whistleblower policy in the Calgary Board of Education.
- The more difficult areas to recruit applicants to include: the automotives field; for special education, in the areas of signing or working with students who are visually impaired; in mathematics; and in the sciences.
- With respect to recruiting teachers for English as a Second Language, the CBE has been fairly successful. Our Human Resources staff is scrutinizing the idea of cultural competence and is working to increase the diversity of our own teaching workforce; however, it has yet to be determined how to collect the data to report on it.
- Another challenge is usually found in staffing our alternative programs, including the
 Montessori alternative program. The past year we actively recruited from across the
 country and we experienced greater success in filling positions. It was noted that there
 are times where we find individuals who may bring the expertise, but they don't pass all
 of the components of our screening process.
- In regards to the work on the development of generic job descriptions and the transition away from an environment based solely on centralized position descriptions, the work is ongoing.

MOVED by Trustee Bazinet:

THAT the Chief Superintendent has reasonably interpreted the provisions of Executive Limitations 7: Treatment of Staff and Volunteers, and the Board of Trustees finds the Chief Superintendent to be in compliance with the policy.

The motion was CARRIED UNANIMOUSLY.

MOVED by Trustee Dirks:

THAT the Board of Trustees commends the Chief Superintendent for the outstanding work undertaken this year by our Human Resources department to recruit and select the significant number of staff required for the system.

The motion was CARRIED UNANIMOUSLY.

MOVED by Trustee Lane:

THAT the Board of Trustees commends the Chief Superintendent for the work in succession planning and, in particular, the establishment of the acceleration pools and the work that has been undertaken in operationalizing those pools.

The motion was CARRIED UNANIMOUSLY.

7.4 <u>Annual Monitoring Report – Executive Limitations 16: Learning Environment/Treatment of Students</u>

Administration responded to Trustees' questions and a summary of the discussion is as follows:

- High schools offer optional courses in World Religions 30 and/or Religious Meaning 20, and it was agreed that Administration would investigate and provide Trustees with the enrolment numbers for those courses at a later date.
- Concerns were expressed about the 2007 data from the High School Exit Survey showing a decrease in the number of students who felt safe at school all the time or often, indicating a drop of 4% from the previous year. It was noted that by next year there will be three years of data, so that an analysis of trends may be useful.
- Administration agreed it would be worthy to incorporate into next year's annual report some data regarding the integration of students from an Integrated Occupational Program (IOP) into kindergarten and elementary and the status of the implementation of the curriculum.

MOVED by Trustee Bazinet:

THAT the Chief Superintendent has reasonably interpreted the provisions of Executive Limitations 16: Learning Environment/Treatment of Students, and the Board of Trustees finds the Chief Superintendent to be in compliance with the policy.

The motion was CARRIED UNANIMOUSLY.

Chief Superintendent Croskery introduced the report noting that it was prepared as directed by the Board to respond exclusively to policy provision 5 to include consideration of the imagineCALGARY Charter and CBE students' active contribution to Calgary's social, economic and environmental wellbeing.

THAT the Board of Trustees approves the reasonable interpretation, indicators and measures provided in the report for the purposes of monitoring Ends 3: Citizenship, policy provision 5.
