Dear W.H. Cushing Workplace School Parents/Guardians:

## Re: Next steps for the closure of W.H. Cushing Workplace School

As you are aware, the current lease for the W.H. Cushing Workplace School expires on July 31, 2016 and no further lease extensions or renewals are available due to the building redevelopment and TELUS's own need for space. Despite best efforts, the Calgary Board of Education (CBE) has been unable to secure a suitable school location in the downtown core to relocate the school.

In September 2015 we informed you that CBE Administration was recommending to the Board of Trustees that necessary steps be taken to effect the closure of the school effective June 30, 2016. Given the unique circumstances, the Board of Trustees asked the Minister of Education for an exemption to formal closure process. The Minister has granted the exemption.

At the February 9, 2016 public Board of Trustees meeting the Board will discuss and confirm proceeding with the closure of W.H. Cushing Workplace School. Parents are invited to attend the meeting that will begin at noon at the Education Centre –1221-8 Street S.W. or to stream the meeting online at <a href="http://www.cbe.ab.ca/about-us/board-of-trustees/Pages/Board-Meetings.aspx">http://www.cbe.ab.ca/about-us/board-of-trustees/Pages/Board-Meetings.aspx</a>.

The Board of Trustees has a procedure in place to allow for public comment at their meetings. If you wish to address the Board at the February 9 meeting, please refer to the following that outlines the process to apply to speak at the meeting. A maximum of five presenters are allowed at each meeting and each presenter will be allowed a maximum of three minutes to speak.
