The following terms and conditions form part of this School Bus Transportation Registration:

- 1 | The personal information contained in this form is collected under the authority of the *Education Act*, the Student Record Regulation and section 4(c) of the *Protection of Privacy Act (Alberta)* for the purposes noted.
- 2 | The cancellation must be received by Sept. 30, 2025, for no financial impact to occur.
- 3 | Refunds: If the student no longer requires transportation services, a refund shall be made upon receipt of the *Request to Cancel School Bus Transportation* form. For cancellations received after the deadline of Sept. 30, 2025, fees will continue to be charged until a cancellation is received, regardless of actual usage or disruption of service. Retro-active refunds will not be issued.
- 4 | In the event of non-payment in whole or in part of the fee or any administration fee, the CBE may pursue collection of fees through legal or other proceedings.
