It will be communicated to parents/guardians by October 2019 when a confirmation email will be sent to all parents/guardians who have submitted a pre-registration. You can cancel your transportation with no financial penalty by filling in the cancellation option in this email and returning it to the Calgary Board of Education by email before October 31, 2019. You may also cancel at any time using your My CBE Account.

Terms and Conditions |

The following terms and conditions form part of this School Bus Transportation Pre-Registration:

- 1 | The personal information contained in this form is collected under the authority of section 23(1) of the School Act and the Student Record Regulation and section 33(c) of the Freedom of Information and Protection of Privacy Act (Alberta) for the purposes noted.
- 2 | **A pre-registration form must be completed before school bus transportation service can be provided to a student.**
- 3 | Participation in the Calgary Board of Education transportation services is contingent upon the child(ren)'s compliance with the CBE Administrative Regulation 6001 - Student Discipline. The Parent/Guardian acknowledges and agrees that the student must comply with CBE's student code of conduct while being transported to and from school.
- 4 | The Parent/Guardian promises to pay the annual transportation fee. Use of service indicates that the Parent/Guardian accepts the terms of the registration and thus the responsibility to pay the annual fee.
- 5 | The Parent/Guardian agrees that if the cheque or PAD is dishonored for any reason, the Parent/Guardian shall be liable to pay to CBE on demand, an NSF fee of **\$35**, in addition to the fee for transportation service.
- 6 | In the case where a student requires transportation service beginning mid-year, a prorated fee is applicable, but must include the fee for the month service begins to and including the end of June. The month in which this registration is entered into shall be treated as a full month for fee payment purposes. Information about payment options is shown on the reverse side of this form.
- 7 | Refunds: If the student no longer requires transportation services, refund shall be made upon receipt of the *Request to Cancel School Bus Transportation* form and receipt of the student's bus pass. Requests must be made within 30 days of the last day of busing and prior to April 30, 2019 to be eligible for a refund. **No refunds will be provided for occasional disruption of service.**
- 8 | Notwithstanding the above provisions concerning refunds, if there are other fees or charges owing to the CBE from the Parent/Guardian, the CBE reserves the right to retain the refund for the purpose of deducting the amount of the refund from the outstanding charges or fees owed to the CBE.
- 9 | The CBE will provide a Zonar Student Card to each student who rides a yellow school bus identified in this registration and any such card shall at all times remain the property of the CBE. Such transportation pass shall not be transferable or assignable to any third party. The Parent/Guardian agrees to ensure that in the event of the loss or theft of the card, immediate written notice thereof shall be provided to the CBE. Parents/Guardians may be required to purchase a replacement card.
- 10 | In the event of non-payment in whole or in part of the fee or any administration fee, the CBE may pursue collection of fees through legal or other proceedings.
- 11 | This pre-registration form is subject to cancellation of transportation services on or by October 31, 2019 with no financial penalty, by return of the confirmation email noted above including completion of the cancellation information contained in that confirmation email.
