As shared in a [presentation to parents Jan.9, 2019](#), the Calgary Board of Education (CBE) administration has decided to recommend consideration of closure of Rosscarrock School to the Board of Trustees.

The school closure process is bound by the School Act and related regulations. If, at the end of the regulatory process, the Board of Trustees makes the decision to close the school, two options are available to re-designate students.

An [online survey](#) is now open for you to share your preference for possible student re-designation.

The options are:

- **Option A** - Students are designated to either Glendale School or Wildwood School and all students are able to walk to school.
- **Option B** – All students move together to Wildwood School; transportation provided for eligible students who live beyond the walk zone for Wildwood School.

We require families to complete this survey to allow us to make the decision that is best for families overall. **The survey will close at midnight, Jan. 17.**
