#### Issue

- We know that for the 2016-17 school year, current k-GR2 students from Piitoayis Family School have the option to move together to the Aboriginal Learning Centre with a focus on early learning; they may also choose to attend their designated community school
- This means that for the 2016-17 school year, Piitoayis Family School will no longer offer k-GR3
- Enrolment at Piitoayis Family School will decline in 2016 when the Aboriginal Learning Centre opens.

## **Impact**

With the opening of the Aboriginal Learning Centre and the declining enrolment at Piitoayis Family School CBE administration is moving forward with a report to the Board of Trustees recommending the Consideration of Closure for Piitoayis Family School.

### **Decision Making**

Any decisions regarding consideration of closure of programs and/or schools will be made by the Board of Trustees.

There will be an opportunity for stakeholders to share their thoughts regarding this decision with the Board of Trustees prior to the decision being made.

#### **Consideration of Closure Process**

#### Steps:

- Board of Trustees
  - Report to the Board of Trustees will be made asking them to consider the closure of Piitoayis Family School.
  - Decision Meeting for Trustees re: Motion to Consider Closure
- Formal Written Notice to Parents
- 3. Public Meeting (Tentative: December/January)
- 4. Report back to Board of Trustees for final decision regarding closure

## **Supporting Students**

Through stakeholder consultation CBE Administration has heard what parents have identified as needed to support students:

- Opportunities for transition plans based on individual student need.
- Current students at Piitoayis Family School will have an option to move to the new ALC when it opens or return to their designated community school.
- A reverse phase-out will occur and the ALC will transition towards accommodating pre-K to GR3 by September 2018.

#### Considerations

- Registration in GR4 and above is closed to new registrations, only those registered at Piitoayis this year are eligible to attend
- A commitment to attending ALC needs to be made in the Spring of 2016 for all current Piitoayis students
- Transportation eligibility and bus stops are determined according to bus registrations submitted
